DENIED THE MEANS FOR THEIR VERY SURVIVAL." THEIR DESPAIR IS BEING MANIPULATED BY THE RIGHT-WING IN RUSSIA TO STIR UP OPPOSITION AGAINST DEFENSE MINISTER GRACHEV AND PRESIDENT YELTSIN.

SENATOR LUGAR INDICATED THAT HE HAD BEEN TOLD IN BOTH LATVIA AND ESTONIA THAT THE GOVERNMENTS THERE ARE FULLY PREPARED TO ENTER NEGOTIATIONS ON CONDITIONS FOR RUSSIAN SOLDIERS, ONCE A DEFINITE TIMETABLE FOR WITHDRAWAL HAS BEEN ESTABLISHED. HE NOTED THAT YELTSIN'S MORATORIUM ON WITHDRAWALS HAD BEEN GREETED WITH CONSIDERABLE ALARM IN THE U.S. SENATE. HE SAID THAT HE SAW NO VIOLATIONS OF THE HUMAN RIGHTS OF RUSSIAN SOLDIERS DURING HIS BRIEF VISIT TO EITHER COUNTRY. AS TO THE QUESTION OF STRINGENT CITIZENSHIP LAWS, LUGAR SAID IT WAS EVERY COUNTRY'S RIGHT TO MAKE ITS OWN RULES. HE SAID HE HAD URGED BOTH LATVIA AND ESTONIA TO SHOW FLEXIBILITY IN THIS AREA.
- D. KOKOSHIN DISAGREED WITH LUGAR'S ASSESSMENT. HE SAID THE LATVIANS AND ESTONIANS ARE PURSUING A CONSCIOUS "POLICY OF EXPULSION" OF THE RUSSIAN-SPEAKING POPULATION. A BODY OF LAWS AND SECRET

RUSSIANS "OCCUPIERS". KOKOSHIN CONCLUDED THAT NEGOTIATIONS HAVE TO CONTINUE, AND INSISTED THAT THERE IS A WITHDRAWAL TIMETABLE.

E. GEN-COL KOLESNIKOV ADDED THAT THE STATUS OF THE RUSSIAN TIMETABLE WHICH HAD BEEN APPENDED TO AN OVERALL AGREEMENT BETWEEN YELTSIN AND LANDSBERGIS WAS UNCERTAIN BECAUSE THE AGREEMENT ITSELF WAS NEVER SIGNED. HE NOTED THAT THE ESTONIANS AND LATVIANS ARE NOT MAKING ANY EFFORT TO NEGOTIATE AND SPEAK INCREASINGLY ONLY OF ONE DATE -- AUGUST 1993 -- THAT THEY SET UNILATERALLY.

F. KOLESNIKOV SAID HE FOUND IT STRANGE THAT THE U.S. ALLOWS ESTONIA TO EXCLUDE RUSSIAN-SPEAKERS FROM CITIZENSHIP WHEN 46 PERCENT OF THE POPULATION IS OF RUSSIAN ORIGIN. HE ASSERTED THAT IN SOME REGIONS THE SECRET

THE RUSSIAN THEATER HAS BEEN DISBANDED; RUSSIANS ARE BEING DENIED EMPLOYMENT; THEY CANNOT PRIVATIZE THEIR APARTMENTS; THEY WILL RECEIVE NOTHING UNDER THE PRIVATIZATION PLANS BEING INTRODUCED NOW. SENATOR LUGAR ARGUED THAT WHAT KOKOSHIN AND KOLESNIKOV WERE DESCRIBING DID NOT FIT WITH WHAT HE HAD SEEN DURING HIS STOPS IN LATVIA AND ESTONIA. HE ARGUED THAT A HARMONIOUS WAY TO CARRY OUT A PHASED, ORDERLY WITHDRAWAL WAS ESSENTIAL: NUNN EMPHASIZED THAT THE BALTIC STATES DENIED HUMAN RIGHTS VIOLATIONS, CLAIMING THAT ONLY A 1500-WORD FLUENCY WAS REQUIRED FOR CITIZENSHIP. NUNN NOTED COMPETING CLAIMS NEED TO BE DEBATED PUBLICLY. THE U.S. WAS CONCERNED ABOUT THE RIGHTS OF RUSSIANS

G. KOLESNIKOV INDICATED THAT THERE IS A PLAN FOR SUCH A WITHDRAWAL. IT CALLS FOR ANOTHER DIVISION TO BE WITHDRAWN IN DECEMBER. HE SAID THE DESIRE OF DEFENSE MINISTER GRACHEV IS TO HAVE NO RUSSIAN TROOPS SERVING OUTSIDE THE BORDERS OF RUSSIA. KOKOSHIN STRESSED THAT NEGOTIATIONS WERE CONTINUING WITH ALL THE BALTIC STATES AND WERE GOING RELATIVELY WELL WITH THE LITHUANIANS. HE PROMISED TO PROVIDE THE SENATORS WITH A REPORT ON SPECIFIC HUMAN RIGHTS VIOLATIONS IN THE BALTICS AGAINST RUSSIAN-SPEAKERS. KOKOSHIN EMPHASIZED THAT RUSSIA COULD NOT SILENTLY STAND BY WHEN A SMALL NATION TRIES TO ENSURE ITS SURVIVAL BY EXPELLING ALL THOSE IN ITS MIDST WHO ARE OF A DIFFERENT NATIONALITY.

NUNN SAID HE WAS NOT A SPOKESMAM FOR THE CLINTON ADMINISTRATION, BUT HE FELT SAFE IN PREDICTING THAT PRESIDENT CLINTON WOULD COMPLY WITH THE 1990 MISSILE DEFENSE ACT AND WOULD, IN COOPERATION WITH RUSSIA, WORK TOGETHER ON EARLY WARNING, AND ON DEFINING THE CONCEPT OF A "LIMITED DEFENSE." HE ALSO SAID WE NEED TO WORK TOGATHER TO DEFINE "LIMITED DEFENSE," TO EXPAND THE ROLE OF NUCLEAR RISK REDUCTION CENTERS, DEVELOP A GLOBAL INVENTORY OF NUCLEAR WEAPONS, TO AID NON-PROLIFERATION OF NUCLEAR WEAPONS AND TO DEVELOP PROCEDURES FOR DEALING WITH TERRORISM DIRECTED AT NUCLEAR FACILITIES.

SENATOR NUNN ALSO NOTED THAT, ALTHOUGH THE U.S. MILITARY DOES NOT YET AGREE WITH THE IDEA, HE WANTS TO SEE ALL NUCLEAR-ARMED BALLISTIC MISSILES FITTED WITH DESTRUCTION DEVICES THAT WOULD PERMIT NATIONAL AUTHORITIES TO DESTROY A MISSILE LAUNCHED WITHOUT PROPER AUTHORIZATION. THE MEETING ENDED WITH EXPRESSIONS OF HOPE FOR RUSSIA'S ECONOMIC REVIVAL AND SECRET
